MIX	Mixed Waste, General (hazardous + radioactive)	\$96 per hour + cost

SBF	Radioactive Bulk Scintillation Media	\$245 per gallon
SVE	Dereg (exempt) Vials	\$490 per cubic foot
SVS	Radioactive Vials w/ half life <30 days	\$500 per cubic foot
SVM	Radioactive Vials w/ half life 30 to 109 days	\$500 per cubic foot
SVL	Radioactive Vials w/ half life >109 days	\$920 per cubic foot
RAW	Retrieval of abandoned &/or hoarded radwaste	\$96 per hour + cost
RIW	Correction of improperly packed radwaste	\$96 per hour + cost
OTH	Other (e.g., sealed sources, plated sources, source mat'l, SNM, etc.)	\$96 per hour + cost

² Increase in radwaste broker fees may require modification of these charge rates.

³ Radwaste rates apply to normally scheduled times for radwaste truck pickup dates; rates may double for other radwaste truck pickup dates and times.

⁴ Disposal of high activity radwaste may result in additional charge due to increased radwaste broker fees.
